The New Year's Eve Ball Drop event will not be taking place this year; the New Year's ball is in very bad condition and cannot be used.

She would like DDA support in promoting a Walk-for-Warmth event on Thursday, February 3, 2022, at 5:00 p.m. prior to the I-500-week Pub Crawl. The Board directed her to the Sault Ste. Marie Convention and Visitors Bureau for this to be included in I-500 promotional materials.

E. Match on Main Application.

Coed is looking to move their flower shop to 724 Ashmun Street, and build an addition on the side of the building for a greenhouse, etc. They plan to hire two additional part-time employees and retain their existing employees. They are seeking matching grant funds in the amount of \$25,000 for a total of \$50,000.
