Public Content

BACKGROUND:

The Street Department is in need of new pickup trucks to replace older fleet vehicles that have exceeded their useful life. Replaced vehicles will be sold at auction or scrapped, with proceeds held in the fund. Stock & Equipment currently has 3 pickup trucks that are unsafe due to their rotted frames, one of which will be replaced with this purchase.

ANALYSIS:

This was put out for bid following the City's purchasing policy and 3 bids were submitted. The bid tabulation and bidder documents are attached.

It is the recommendation of administration that the City purchase the truck from the second lowest bidder, Soo Motors Ford, as the truck is currently available and it would be utilized this winter season. The lowest bidder did not have stock available until next year.

FISCAL IMPACT:

The purchase of this new pickup truck was budgeted for in the Capital Equipment Improvements for the current fiscal year at \$65,000. The selected bid is \$1,309.00 over the budget. With the congruent street sweeper bid coming in \$48,500 under budget in this same line item, no budget amendment is needed. Unspent funds as of the end of the fiscal year will remain in Stock and Equipment Fund.
